1. One (1) completed application form with two photos. (2 photos required)

(Passport must be at least 6 months validity with available visa page.)

VISA INFORMATION

- The **stay** for the Business Visa is **70 days**, which is extendable.

- The **validity** of the Business Visa (Single Entry) is **3 months** from the date of issue, which cannot be renewed or refunded. Consulate will issue visa for completed application as soon as receive it. Consulate will not take any responsible for too early and too late applications.

- Multiple Journey Entry Business Visa (MJEV) may be obtained for a fee of **USD200 (for 3 months)**, **USD 400 (for 6 months)** and **USD 600 (for a year)** at the discretion of the Embassy Official.

(Note: First time visitors for business purpose are not eligible to apply MJEV)

- Digital Photos: Digitally reproduced photographs must be reproduced without discernible pixels or dot patterns.
- **Photocopied photographs are NOT accepted.**
